



#### **Carla Wright**

I am blessed to own my home for more than 20 years in the same community that I love and was raised in and has been a part of for more than 50 yrs. For decades in many ways, we have been overlooked, underserved and ignored. I have spent my entire life advocating for decent, affordable housing, providing comfort to the homeless, managing child daycare centers that allowed mothers to re-enter the workforce and take of their families, helping recovering addicts to turn their lives around, counseling those who lost the will to live, instilling hope in them and heightening community awareness about the crisis of missing persons.

I have tried to take the pulse of the community, asking residents what they want and need then seeking to translate that into fair and equitable policies. If I am honored to be elected as the ninth ward alderperson I will listen to the people and help craft legislation to address their concerns about crime, economic opportunities and overall quality of life.

My history with the New 11th ward is not only growing up but being raised. My mind overflows with a flood of childhood memories visiting Fairgrounds Park with my siblings, cousins and grandfather. The bittersweet feeling in remembering the last day of seeing many of my friends from Ashland Elementary School as we stood and smiled for our eighth-grade graduation picture. Thinking of my first day at Beaumont high school and the excitement that I felt with selected to join the PomPom Squad. I am an alumnus of Harriss-Stowe State University.

I have experienced being a provider of social services and a recipient. I have advocated for city residents here in St. Louis, Missouri's capital Jefferson City and in Washington, D.C., the nation's capital fighting for the people, fighting for justice standing on the right side of history. By becoming an alderperson I will gain the ability to vote on and write legislation to make changes that the people want and that will improve the 11th Ward. I want to focus on closing the wealth gap, eliminating crime and more attention on mental health care, and services needed.
My work experience includes being a top producer with American National Life Insurance where I was a member of the President's Club. I am certified by the state of Missouri as a director of child daycare facilities with an unlimited number of children (99 or more). #### Laura Keys

The Board of Aldermen through the public safety committee can exercise oversight of the police department, compel the chief of police and the public safety director to report to the aldermanic committee and participate in hearings and craft legislation that directly addresses professional standards to which the police hierarchy must adhere.

## **Question 9**

With the passage of BB 116, we will see the beginnings of a Universal Basic Income program for residents of the city. The current program outlines that you have to be a city resident, have a child(ren) under the age of 18 enrolled in the public school district, and not exceed 170% of the Federal Poverty Level. How do you feel about this Universal Basic Income? If you support UBI, how would you seek to expand this program to include those that don't fall under these current requirements? (I.E. Homeless, those city residents who chose to enroll students into city charter schools, etc.)

#### **Carla Wright**

I support UBI and in my opinion it should extended to our unhoused and high-risk individuals, seniors, disabled and low-income homeowners.

What concrete steps will you take to alleviate homelessness in the City of St. Louis?

#### **Carla Wright**

I support building more tiny houses, providing mandatory training and completion of life skills programs; employment referrals and mental health care access.

#### Carla Wright

Economic development, expanding light rail, affordable housing, fixing roads and bridges, crime prevention, create more jobs and businesses, improve the school system, provide more mental health care services.

One of the greatest factors around increasing economic mobility in the region is through increasing public transit access. How do you plan to make public transit more accessible across the city?

### **Carla Wright**

I plan to make public transit more accessible across the city by supporting efforts by the greenway efforts to connect all of the metrolink stations and working with Metro to add more routes and increase the number of bus shelters and frequency of trips throughout the system.

## **Question 14**

Issues of environmental racism affect many families in St Louis. How do you plan to address issues such as lead poisoning, food apartheid, illegal dumping, and air quality that leads to higher rates of asthma?

Ban synthetic chemical-based herbicides and pesticides, encourage the use of natural herbicide and pest control solutions; continue to work closely with environmental groups to advocate for environmentally friendly policies that enhance public health and limit exposure to harmful pollutants.

## **Question 17**

Do you support the demand for a citywide reparations process? Please explain your position.

Yes, I support the demand for reparations. The city of St. Louis benefitted in its origins from participation in the enslavement economy. Slave labor contributed to the development of agriculture, barge traffic, construction of buildings, trade and finance.

## **Question 18**

What is your position on privatization as it relates to city assets? Please explain your position.

#### **Carla Wright**

I am against privatization. It removes oversight and control of the residents over city services and hands it over to private companies more concerned with profit than service.

What is your position on city/county reunification? Please explain your position.

#### **Carla Wright**

I am against the two merging. I don't think that is a good fit at this time. The plan put forth by Better Together actually indicates the county would benefit more than the city from the merger. This lopsided result would not be in the interest of city residents.
